### Des Moines Valley Friends: The State of the Meeting - Prepared for Iowa Yearly Meeting Conservative 2024 by DMVF Ministry and Counsel

Diversity and new people joining us are two big strengths of our meeting. We also strive to be fully inclusive of Zoom attenders in the life of the meeting. Another strength is how we care for one another.

Our diversity sometimes leads to tensions among community members, such as over differing opinions regarding appropriate ministry. We have asked for individuals to practice more discernment about when to rise to speak during waiting worship and how to offer ministry.

As a community we have been delighted with the movement of the Spirit among us this past year. We are grappling with many changes and challenges but there is a new sense of possibility among DMVF and a growing sense that we have much to offer the wider community. The arrival of new attenders has brought us new Spiritual energy, helping us to put our faith into action in new ways.

Sometimes our worship feels deeply grounded, whether or not there is vocal ministry. Other times it feels less Spirit-led and more secular, depending upon the messages offered on a given First Day and the receptivity each of us brings with us to meeting.

Generally, we need more individuals to participate in meeting for worship with attention to business. As a community we do not seem to fully understand this responsibility. Our collective skills around doing our business after the manner of Friends will be enhanced with more attendance on a more regular basis.

We enjoy lively discussions when we gather to consider the query each month. Participation has been good and the sharing has provided one important venue for our community to deepen our relationships with one another. The queries continue to challenge us and continue to encourage our spiritual growth.

The spiritual life of our meeting will continue to be strengthened as we deepen the relationships between us. Witnessing against racism by many community members and generous informal sharing after worship both help deepen our connections to one another.

### A Quaker Minute William Penn Statue Controversy

The National Park Service has retracted plans to remove a statue of the Quaker founder of Pennsylvania, William Penn, from a small pocket Park in Philadelphia. The Biden administration and the Park Service have been under intense pressure from conservative media for "cancelling" William Penn out of the history of colonial America in favor of a "woke" outdoor museum dedicated to precolonial Native American culture. In this context, "woke" refers to having an active awareness of systemic injustices and prejudices, especially those involving the treatment of ethnic, racial or sexual minorities.

William Penn was a 17th Century wealthy British aristocrat whose father was Lord of the Admiralty under King James. Young Penn embarrassed his family by converting to Quakerism, preaching and pamphleteering for the Quaker cause, getting expelled from Oxford University and imprisoned in the Tower of London for his Quaker activities. The family sent William to the New World to administer Pennsylvania to hide his antics from London society.

William Penn made his Pennsylvania a "Holy Experiment" where people of diverse backgrounds and religions would live together in peace.

## Approval of Minutes from May 7. 2024 Meeting for Worship with Attention to Business(

**Minute**: Friends approved the minutes from the May Meeting for Business, with appreciation to Deb Fisch for stepping in for the recording clerk.

### Ministry & Counsel Committee Report (Jim Dietz-Kilen)

### Des Moines Valley Friends Meeting June 2024 Ministry & Counsel Report

In Attendance: Dorothy Lifka, Andrea Holveck, Gordon Bivens & Jim Dietz-Kilen (convener).

We gathered in silence at our appointed time of 8:30 am on First Day.

We shared updates regarding Friends with health struggles or other concerns and considered how we might best provide support for these individuals.

We next reviewed the balances of the Sharing and Quaker Education, Enrichment & Advocacy Funds.

The draft State of the Meeting report, which was circulated to the committee following last week's meeting, was the next

item. With just a few additional tweaks, it was approved to be submitted for approval at the next Business Meeting.

Next, we discussed the new process for introductions, sharing joys & concerns and announcements. In general, we think it is working fairly well. We suggest that the clerk or a host simply acknowledge people on zoom, as the least awkward way of handling those introductions. Committee members felt that "popcorn" sharing of joys & concerns is working well.

Our last agenda item was a request from Michael Luick-Thrams for a clearness committee. Michael specifically requested, via clerk Carol, that his clearness committee be organized by her, as clerk, rather than by M&C. The committee consulted IYM©'s Faith and Practice for guidance. That books states that "[t]hose who wish the help of a clearness committee may ask the clerk of the Meeting or of Ministry and Counsel that such a committee be formed." On that basis, we advise Carol that it is appropriate for her to proceed in working with Michael to form a committee for clearness.

Discussion: Friends discussed the State of the Meeting report and whether it should be circulated for comment before submitting to Yearly Meeting. The Clerk will circulate by email.

Friends also discussed the new process for sharing joys and concerns after Meeting for Worship. Friends expressed concerns that individuals feel hesitant to share with the new process, and only share if their

joy/concern rises to a level that is similar to a message. Others expressed concern that they feel less connected to Friends than when joys and concerns were shared longer with introductions. Friends had several suggestions about how to best address these concerns. The Clerk will bring the concern to Ministry and Counsel for further consideration.

**Minute:** Friends approved the report.

### Finance Committee & Budget Report (Catherine Dietz-Kilen)

Friends were provided with the following documents by email: April Designated Funds, Funds Summary, and Receipts & Expenses

### DMVF Finance Committee Minutes, May 15, 2024 (via Zoom)

**Attendees:** Catherine Dietz-Kilen, Katie Jacoby, Dorothy Lifka and Dick Douglass

1. The Finance Committee reviewed the proposed budget for July through December 2024. Because there was little discussion at the previous Business Meeting, we were concerned about presenting this budget to be approved at the June Business Meeting. The Committee hopes to have a robust conversation about the budget at the June Business Meeting with the likelihood of delaying the final approval until the July Business Meeting, thereby giving the Finance Committee an opportunity to address any questions or concerns raised by the Business Meeting in

- June at the next Finance Committee Meeting.
- 2. Our next scheduled meeting will be on the third Wednesday of next month at 9:00 a.m. via Zoom, June 19, 2024.

A note on our apportionment, from Catherine: The apportionment for DMFV for fiscal year 2023-24 was \$14, 500, not \$12,000. The original proposed budget had \$12,000 for our apportionment, but then we received an unexpected donation and revised the budget to \$14,500.

We have not yet approved a budget for the next year. Because DMVF is switching to a calendar year, the next budget will be for July - December 2024. The finance committee has proposed \$7,500 for the six-month period. Unless there is a drastic change in DMVF's finances, I believe that we will budget \$15,000 in the calendar year 2025.

### Katie Jacoby reviewed the Income/Expense report.

Friends were provided with the following Notes Re DMVF Proposed Budget (April 30, 2024):

- 1. Because the Meeting is moving to a calendar year for its fiscal year, the proposed budget is for six months.

  Therefore, most annual items from the previous budget have been listed at one-half of last year's annual amount.
- 2. The amount for snow removal/lawn care is reduced because we have a new provider who is less expensive.

- 3. The amount for the insurance that we share with Friends House has been increased because the cost has gone up. It comes due in October, so the entire year's amount is included in this half year budget.
- 4. Carpet cleaning. No amount is included for carpet cleaning because the amount budgeted for carpet cleaning has not been spent during the last two fiscal years.
- 5. There is a new line of insurance paid just by the Meeting. This past year, the Finance Committee realized that the Meeting itself was lacking coverage under the Meeting House policy and felt it was best that we take out our own. We did. Like the insurance that we pay through Friends House, it all comes due during the second half of the year, so the entire amount appears in the proposed budget.
- 6. Religious Education. The funding amount proposed, \$125.00, is the amount that was requested by the Committee.
- 7. Under Affiliated
  Contributions, we have added
  Friends Peace Teams in the
  amount of \$100. Because all
  of the other Affiliated
  Contributions have received
  donations during this
  calendar year, we have not
  listed additional donations for
  Affiliated Contributions
  beyond Friends Peace Teams.
- 8. Our yearly Meeting allocation has been restored to \$15,000.00 annually. Half of which would be due

- during the second half of 2024.
- 9. The Ministry and Counsel Sharing Fund has been increased to \$30 per month.
- 10. The annual amount for Peace and Social Concerns has been increased to \$1,500.00, therefore \$750.00 is listed for the 6-month budget for Peace and Social Concerns.
- 11. The Property Management Fund has been unfunded for some years. We recommend starting to put money back into that fund at the rate of \$2,000.00 annually, so \$1,000.00 appears for the sixmonth budget.
- 12. There has been some discussion about budgeting additional funds for the Outreach Committee for the purpose of installing a sign on our property. We asked the Outreach Committee to look into the cost of installing such a sign should they wish to do so, so that, if appropriate, funds can be budgeted for our next full year budget for 2025.
- 13. The donations that we would need to be able to handle, this six-month budget would be \$17,515.00, keeping in mind that with both insurance premiums due during this six month period that the proposed budget in reality is a bit more than half of the one-year budget. During the 6-month period of July through December of 2023, we received donations of \$17,944.00.

Dorothy reviewed the proposed 6-month budget for the period from July – December 2024. Friends discussed the need for

carpet cleaning and requested that the committee consider adding this to the current budget rather than waiting until 2025. Friends expressed special appreciation to the budget committee for bringing the IYMC apportionment back to its previous level, for considering matters related to property management, and for increasing the insurance.

Minute: Friends approved the proposed budget with one modification to provide for carpet cleaning prior to the end of the year. Friends expressed their deep appreciation for the hard work of the budget committee.

The Nominating Committee met on June 3, 2024. The committee discussed the Meeting's transition from a fiscal to calendar year for accounting purposes and for committee assignments. To facilitate this transition, the Nominating Committee is requesting that Friends continue to serve on their current committees and/or in their current leadership roles until the end of the current calendar year. Anyone who is not able to continue serving in their current capacity(ies) should contact a member of the Nominating Committee.

Members of the Nominating Committee will contact Friends in the early fall about committee assignments and positions for the 2025 calendar year.

The Nominating Committee is in the process of putting together an ad hoc committee of Friends who are interested in immigration issues and who can manage the Meeting funds set aside for the purposes of addressing concerns about immigration. Once formulated, the ad hoc committee will be asked to prepare a committee description, outlining the purpose

and work of the committee. Friends interested in serving on the ad hoc committee should contact a current member of the Nominating Committee (Claire, Dick, Andrea).

David Drake will be stepping onto the Nominating Committee in early fall for a three-year term. He replaces Claire Cumbie-Drake who is rotating off. Other members of the committee are Andrea Holveck and Dick Douglass.

*(continued from page 1)* He signed a compact with local Indian tribes guaranteeing their right to self-governance on their own lands and paying them a fair price for the lands he purchased for the

In his Frame of Government. Penn provided for secure private property, free enterprise, free press, trial by jury and religious toleration – all civil rights that would be incorporated a century

later in the US Bill of Rights.

Though Penn embraced several innovative democratic ideals, he was not a "liberal" by21st Century standards. His magistrates imposed a rigid moral code on all residents. He owned slaves. He enticed new settlers to Pennsylvania with exaggerated advertising. And his haphazard administration brought the colony into bankruptcy.

William Penn was a practicing Quaker and imperfect human being who is remembered by Friends as someone whose life spoke of God's Love and the power of faithful action.
